Your booking fee is non-refundable, unless your Evissa is unable to fulfill the booking, at which time a full refund of your booking fee will be given.

Cancellation of any booking by the Customer must be given in writing by post or email and can only be confirmed once Evissa acknowledges the cancellation in writing. The following cancellation fees apply if the booking is cancelled by the Customer:

Up to 3 months prior to the date	Non refundable booking fee only
3 months – 6 weeks prior to the date	50% of the amount quoted on your booking form.
6 weeks prior to the day and under	100% of the amount quoted on your booking form.

The above fees only apply once the trial has taken place and the Customer has confirmed her requirements with Evissa for the day, and the Booking Form has been signed.
